Presentation by Dr. Rosa and Dr. Solar (New Bedford coalition to save our schools)

- Efforts focused on resisting charter expansion in the city and building strong quality public schools.
- The new charter school wants 1,580 seats, costing the New Bedford public school (NBPS) system \$50mil and layoffs.
- A deal cut behind closed door without community involvement 480 seats (former Kempton seats).
- The charter school entry will not be by lottery but instead the public school will assign students to the charter school this has never been done before in MA.
- This was done to circumvent question #2.
- Department of education sees NB as a model that can be implemented across MA in Holyoke, Brockton, etc.
- There are a number of externalities not mentioned that will cost NB more than was stated.
- The NB kids will be forced to attend the charter school despite parents input.
- Push back is against mayor Mitchell and the state.
- Public schools should be the default and parents should opt-in rather than forcing students to opt-out of sending their kids to the charter schools. The opt-out is not guaranteed to be honored by the superintendent. The form will also create a language barrier as many parents might not fully understand the gravity of the form.
- Creating the New Bedford students bill of rights where students, middle and high school students, are articulating the type of school system they need. It will also inform students of their rights such as food quality, school infestation by mice, Police officers presence in schools.

- Asking the participation of the NAACP, especially the young folks in the G. body.
- o <u>LaSella H. next steps:</u> To put together a forum with the NBCSOS, NAACP NB college chapter, and NAACP NB branch.
